## STUD SERVICE CONTRACT

This is to certify that our stud dog, \_\_\_\_\_

The fee for this mating is a cash fee of \$ \_\_\_\_\_, paid at the time of service or

taken in lieu of stud fee it (they) will be the choice of the stud owner to be taken at  
approximately 8 weeks of age. The puppy(is) will carry the kennel name of stud owner and  
same will select the registered name.

## CONDITIONS OF SERVICE

1. Payment is in full of the stud fee is expected at the time of first service unless otherwise specified in the initial arrangements for breeding.
2. It is agreed, hereby, that the owner(s) of the stud dog are not obligated to sign the application for registration of this litter until the stud fee has been paid in full, as well as all other outstanding expenses with other parties, regarding this breeding, that have been mutually agreed upon.
3. If there is a tie or the breeding is otherwise consummated there will be no refund of the stud fee in whole or in part.
4. If the bitch fails to whelp, the owners of the bitch must notify the stud dog owner of this fact with 10 days of the whelping date. The same stud dog at the next heat will give a return service unless otherwise agreed upon with the stud owner. Lack of notification as indicated above will forfeit return service.
5. If the stud dog should die or become otherwise incapacitated for breeding purposes before the return service is given, the owner of the stud dog retains the right to offer the services of another stud dog in their possession at that time.
6. The stud dog owner(s) reserves the right not to breed their dog to this bitch should she be misrepresented in any way. All documents give the owner(s) are accepted as true. If any irregularities are subsequently identified, this agreement is null and void, and the bitch owner(s) agrees to pay all expenses incurred.
7. If the bitch changes ownership, any return service will be at the discretion of the stud owner. In certain cases, a substitute bitch may be accepted for the return of service, but again at the discretion of the stud owner.
8. Live birth of two or more puppies will be considered a litter.
9. It is understood that the stud dog owner shall maintain reasonable care of the bitch while at the stud owner's facility or under the care of the stud owner or agent. The stud owner

or their agent shall not be held responsible for any loss, injury, or death of the bitch while under their supervision or while in transport by private or commercial carrier.

10. If the bitch owner(s) decides to do breeding by artificial insemination they are totally responsible for all costs involved as well as making all the arrangements for the collection, shipment, and insemination.
11. The owner(s) of the bitch agrees to pay all expenses concerned with the shipping of bitch to and from the stud owner(s).
12. The owner(s) of the bitch agrees to pay all veterinary cost should they be necessary.
13. All bitches shall be tested free and clear of brucellosis and have a normal mycoplasma culture.
14. The owner(s) of the bitch will not under any circumstances place any puppy with a commercial or retail pet establishment for any reason. The stud dog owner(s) strongly suggest that all puppies be sold under contract, and that any puppies placed in second homes also exclude pet wholesalers and retailers. The stud dog owner(s) also suggest placing all non-breeding puppies on a spay/neuter agreement.
15. The bitch owner(s) will supply the stud owner(s) with a list of all puppy owners, or other puppy placement regardless of the ownership, giving names, addresses and telephone numbers. A complete list will be made available to the stud owner(s) on or before the puppies are six months.
16. The undersigned owner and co-owners represent that they are duly authorized to sign this contract and make this a binding contract. This contract may only be altered by mutual consent of all parties.
17. The parties acknowledge that in the event there is a dispute between the parties, the forum for resolution of any claims shall be Whitley County, Kentucky.
